A. CALL TO ORDER

District Manager Michael McElligott called the October 12, 2021, Regular Board Meeting of the Hypoluxo/Haverhill Community Development District to order at 9:01 a.m. at the Centurion Tower, 1601 Forum Place, West Palm Beach, Florida 33401.

B. PROOF OF PUBLICATION

Mr. McElligott presented proof of publication that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on October 1, 2021, as legally required.

C. ESTABLISH A QUORUM

Mr. McElligott determined that the attendance of the following Supervisors constituted a quorum, and it was in order to proceed with the meeting: Chairman Tom Messler, Vice Chairman Bernard Gatlin, and Supervisors Paul Patton and Brett Osinski.

D. ADDITIONS OR DELETIONS TO THE AGENDA

There was a request to add a discussion about changing the meeting time. There were no objections so that item was added to the agenda under new business.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. July 14, 2021, Regular Board Meeting

Mr. McElligott presented the minutes of the July 14, 2021, Regular Board Meeting and asked if there were any changes and/or corrections. There were no corrections noted. A **motion** was then made by Mr. Patton, seconded by Mr. Gatlin, and unanimously passed to approve the minutes of the July 14, 2021, Regular Board Meeting, as presented.

2. Consider Resolution No. 2021-05 – Adopting a Fiscal Year 2020/2021 Amended Budget

Mr. McElligott presented Resolution No. 2021-05, entitled:

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE HYPOLUXO/HAVERHILL COMMUNITY DEVELOPMENT DISTRICT AUTHORIZING AND ADOPTING AN AMENDED FINAL FISCAL YEAR 2020/2021 BUDGET ("AMENDED BUDGET"), PURSUANT TO CHAPTER 189, FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE.

A **motion** was made by Mr. Patton, seconded by Mr. Gatlin and passed unanimously to adopt Resolution No. 2021-05, as presented.

3. Discussion Regarding Meeting Start Time

Mr. McElligott explained that the Board can choose to change the start time of the meeting if they wish, we will just need to run a new advertisement to reflect the change. After a discussion among the Board, a **motion** was made by Mr. Patton, with a second from Mr. Messler, to change the meeting start times to 9:00am from 8:30am going forward. That **motion** passed unanimously.

Mr. McElligott noted that it was likely that the Board would not meet again until after the holidays, and that he would email the Board to confirm closer to the scheduled meeting dates those cancellations.
