A. CALL TO ORDER

District Manager Michael McElligott called the September 13, 2022, Regular Board Meeting of the Hypoluxo/Haverhill Community Development District to order at 9:02 a.m. at the Conference Room at Special District Services, Inc, located at 2501 A Burns Road, Palm Beach Gardens, Florida, 33410.

B. PROOF OF PUBLICATION

Mr. McElligott presented proof of publication that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on December 30, 2021, as legally required.

C. ESTABLISH A QUORUM

Mr. McElligott determined that the attendance of the following Supervisors constituted a quorum, and it was in order to proceed with the meeting: Chairman Tom Messler, Vice Chairman Bernard Gatlin, and Supervisors Brett Osinski and Ashkan Dehghani.

Staff in attendance were District Manager Michael McElligott of Special District Services, Inc., and District Counsel Scott Cochran of Billing, Cochran, Lyles, Mauro & Ramsey, P.A. attended via phone.

D. ADDITIONS OR DELETIONS TO THE AGENDA

Mr. McElligott asked to add to the agenda an item to consider a rate increase request by the district lake maintenance company Superior Waterways. There was no objection by the Board so that item was added under new business.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. May 10, 2022, Regular Board Meeting and Public Hearing

Mr. McElligott explained that he received the request just a few days ago so the request is not in the meeting books, but Mr. McElligott did have copies that he passed out. Mr. McElligott also explained that based on the budget the Board has approved for lake maintenance the District will be able to cover the increase request.

After some discussion among the Board members, a **motion** was made by Mr. Osinski, with a second by Mr. Messler to approve the 3% rate increase requested by Superior Waterways. That **motion** passed **4-0**.

RE: Hypoluxo/Haverhill Community Development District Auditor Renewal
At the September 11, 2019 Hypoluxo/Haverhill Community Development District Board Of Supervisors meeting, the firm of Grau & Associates was selected to perform the 9-30-2019, 9-30-2020 and 9-30-2021 year end audits of the District with an option to perform the 9-30-2022 and 9-30-23 audits.
The fees for the 9-30-2019 audit were \$3,300. The fees for the 9-30-2020 audit were \$3,400. And the fees for the 9-30-2021 audit were \$3,500. The proposed fees for the 9-30-2022 audit is \$3,600, which is the budgeted amount for audit fees for Fiscal Year 2022/2023. The proposed fee for the 9-30-2023 audit is \$3,700.
Management is pleased with the professionalism and the competence of the Grau & Associates partners and staff; therefore, management recommends that the Board approve the renewal option for the Fiscal Year Ending 9-30-2022 and 9-30-2023 audits for Grau & Associates.
