A. CALL TO ORDER

District Manager Michael McElligott called the February 14, 2023, Regular Board Meeting of the Hypoluxo/Haverhill Community Development District to order at 9:03 a.m. at the Conference Room at Special District Services, Inc, located at 2501 A Burns Road, Palm Beach Gardens, Florida, 33410.

B. PROOF OF PUBLICATION

Mr. McElligott presented proof of publication that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on September 30, 2022, as legally required.

C. ESTABLISH A QUORUM

Mr. McElligott determined that the attendance of the following Supervisors constituted a quorum, and it was in order to proceed with the meeting: Chairman Tom Messler, Vice Chairman Bernard Gatlin, and Supervisor Ashkan Dehghani.

Staff in attendance were District Manager Michael McElligott of Special District Services, Inc., and District Counsel Scott Cochran of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

D. DECLARE VACANCIES AND CONSIDER NOMINATIONS

Mr. McElligott explained that no one qualified for Seats 3 & 4 at the election in November.

There was a **motion** by Mr. Dhegihan, with a second by Mr. Messler to declare seat 3 & 4 vacant. That **motion** passed **3-0**.

There was a **motion** by Mr. Gatlin, with a second by Mr. Messler, to appoint Mr. Brett Osinski to Seat 3 for a 4 year term. That **motion** passes **3-0**.

Seat 4 remains vacant at this time.

E. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

F. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

G. APPROVAL OF MINUTES 1. November 8, 2022, Regular Board Meeting

HYPOLUXO/HAVERHILL COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING FEBRUARY 14, 2023

Mr. McElligott presented the minutes of the November 8, 2022, Regular Board Meeting and asked if there were any changes and/or corrections. There were no corrections noted. A **motion** was then made by Mr. Gatlin, seconded by Mr. Messler, and unanimously passed to approve the minutes of the November 8, 2022, Regular Board Meeting, as presented.

H. OLD BUSINESS

1. Update Regarding Tree Trimming Policy

Mr. McElligott informed the Board that he was able to get a hold of Mr. Roth and he is working on this policy with the landscape architect firm the District used when doing the big tree trimming last year. Mr. McElligott will bring the policy to the Board to approve as soon as it is ready.

2. Discussion Regarding Irrigation Permit Policy

Mr. McElligott presented the Permit form that District Engineer, Mr. Roth sent. Mr. McElligott explained that we received the permit information right before the meeting so Mr. Cochran has not had a chance to review. Mr. Cochran said he would need to review and bring back a resolution to the next meeting to begin the policy making process.

A motion was made by Mr. Dehghani, seconded by Mr. Messler, to direct Mr. Cochran to review the irrigation permit language and bring back a policy resolution to the next meeting. The motion passed **3**-**0**.

I. NEW BUSINESS

1. Consider Approval of Adjustment to District Council Fee Structure

Mr. Cochran reviewed the rate fee increase letter passed out by Mr. McElligott. Mr. Cochran highlighted that the district council has not raised their fee since 2002. Mr. Cochran stated that if passed, the new rates would be effective April 1st, 2023.

After some discussion among the Board, a **motion** was made by Mr. Dhegihan, with a second by Mr. Gatlin, to approve the District Council Rate Fee structure increase as presented. That **motion** passed **3**-**0**.

J. ADMINISTRATIVE MATTERS

Mr. McElligott noted that the next meeting would likely be in April.

K. BOARD MEMBER COMMENTS

There were no comments from the Board Members.
